Eligibility: The 'Bay Area Craft Beer Festival Ticket Giveaway' is open only to those that 'Like' or 'Follow' 'Amtrak San Joaquins Facebook Page' 'tag Amtrak San Joaquins Instagram Page' 'tag Amtrak San Joaquins Twitter Page' and who are 21 years of age or older as of the date of entry. The 'Bay Area Craft Beer Festival Ticket Giveaway' is only open to legal residents of the state of California and is void where prohibited by law. Employees of San Joaquin Joint Powers Authority, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the 'Bay Area Craft Beer Festival Ticket Giveaway'. The 'Bay Area Craft Beer Festival Ticket Giveaway' is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, the 'Bay Area Craft Beer Festival Ticket Giveaway' ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of the San Joaquin Joint Powers Authority as final and binding as it relates to the content of the 'Bay Area Craft Beer Festival Ticket Giveaway'.

3. 'Bay Area Craft Beer Festival Ticket Giveaway' Period: Entries will be accepted at Amtrak San Joaquins Facebook Page starting on April 5, 2017 and ending April 17, 2017. All Amtrak San Joaquins Facebook Page entries must be received by 11:59PST April 17, 2017.

4. How to Enter: The 'Bay Area Craft Beer Festival Ticket Giveaway' must be entered by taking a photo and sharing it by tagging Amtrak San Joaquins on Facebook, Instagram, or Twitter. Participants must also like/follow/ subscribe to at least one of Amtrak San Joaquins' social media channels: Facebook, Instagram, Twitter or YouTube. Examples of photos include, but are not limited to, a favorite brewery, enjoying a beverage on the train, or a favorite view from the train. The entry must fulfill all 'Bay Area Craft Beer Festival Ticket Giveaway' requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the San Joaquin Joint Powers Authority. You may enter only once. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of the San Joaquin Joint Powers Authority.

5. Prizes: The Winner of the 'Bay Area Craft Beer Festival Ticket Giveaway' (the "Winner") will receive two tickets to the Bay Area Craft Beer Festival on April 22, 2017. No cash or other prize substitution shall be permitted. The prize is nontransferable. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes

permission for the San Joaquin Joint Powers Authority to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner will be selected by a random drawing under the supervision of the San Joaquin Joint Powers Authority. Winner will be notified based on the social media channel the photo was submitted on. For Facebook, Winner will be notified by Facebook Direct Messenger within one (1) day following selection of Winner. For Instagram, Winner will be notified by Instagram Direct Message within one (1) day following selection of Winner. For Twitter, Winner will be notified by Twitter Direct Message within one (1) day following selection of Winner. The San Joaquin Joint Powers Authority shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 1 day from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in the 'Bay Area Craft Beer Festival Ticket Giveaway' is conditioned upon compliance with any and all federal, state, and local laws and regulations.

Terms & Conditions: The San Joaquin Joint Powers Authority reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the 'Bay Area Craft Beer Festival Ticket Giveaway' should virus, bug, non-authorized human intervention, fraud, or other cause beyond the San Joaquin Joint Powers Authority's control corrupt or affect the administration, security, fairness, or proper conduct of the 'Bay Area Craft Beer Festival Ticket Giveaway'. In such case, the San Joaquin Joint Powers Authority may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the San Joaquin Joint Powers Authority. The San Joaquin Joint Powers Authority reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the 'Bay Area Craft Beer Festival Ticket Giveaway' or violates these Terms & Conditions. The San Joaquin Joint Powers Authority has the right, in its sole discretion, to maintain the integrity of the 'Bay Area Craft Beer Festival Ticket Giveaway', to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by 'Bay Area Craft Beer Festival Ticket Giveaway' rules; or the use of bots, macros, scripts, or other technical means for entering. 10. Limitation of Liability: By entering, You agree to release and hold harmless the San Joaquin Joint Powers Authority and its subsidiaries, affiliates, advertising and promotion agencies, partners,

representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the 'Bay Area Craft Beer Festival Ticket Giveaway' and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error in the administration of the Promotion or the processing of entries.

Further, in any such dispute, under no circumstances shall participant be permitted to obtain awards for, and hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this 'Bay Area Craft Beer Festival Ticket Giveaway'). Participant further waives all rights to have damages multiplied or increased.
