3. 'Sacramento Kings Ticket Giveaway' Period: Entries will be accepted at Amtrak San Joaquins Facebook Page starting on March 3, 2017 and ending March 5, 2017. All Amtrak San Joaquins Facebook Page entries must be received by 11:59PST March 5, 2017.

4. How to Enter: The 'Sacramento Kings Ticket Giveaway' must be entered by tagging another Facebook user in the 'Comments Section' of Amtrak San Joaquins 'Sacramento Kings Ticket Giveaway Post' and by 'Liking' the Amtrak San Joaquins Facebook Page. The entry must fulfill all 'Sacramento Kings Ticket Giveaway' requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the San Joaquin Joint Powers Authority. You may enter only once. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of the San Joaquin Joint Powers Authority.

7. Winner Selection and Notification: Winner will be selected by a random drawing under the supervision of the San Joaquin Joint Powers Authority. Winner will be notified by Facebook Direct Messenger within five (5) days following selection of Winner. The San Joaquin Joint Powers Authority shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 2 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. In such case, the San Joaquin Joint Powers Authority may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the San Joaquin Joint Powers Authority. The San Joaquin Joint Powers Authority reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the 'Sacramento Kings Ticket Giveaway' or violates these Terms & Conditions.
