Eligibility: The 'Mother's Day Contest' is open only to those that 'Like' or 'Follow' 'Amtrak San Joaquins Facebook Page,' 'Follow' 'Amtrak San Joaquins Instagram Profile' or 'follow' 'Amtrak San Joaquins Twitter Profile.' The 'Mother's Day Contest' is only open to legal residents of the state of California and is void where prohibited by law. Employees of San Joaquin Joint Powers Authority, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the 'Mother's Day Contest'. In addition, You agree to accept the decisions of the San Joaquin Joint Powers Authority as final and binding as it relates to the content of the 'Mother's Day Contest'.

3. 'Mother's Day Contest' Period: Entries will be accepted at Amtrak San Instagram Profile starting on May 8, 2018 and ending May 9, 2018. All Amtrak San Joaquins Facebook Page, Instagram Profile and Twitter Profile entries must be received by 11:59PST May 9, 2018.

4. How to Enter: The 'Mother's Day Contest' must be entered by commenting or replying to the Mother's Day Contest Announcement Post on Instagram. Participants must also like/follow/ subscribe to at least one of Amtrak San Joaquins' social media channels: Facebook, Instagram, Twitter or YouTube. The entry must fulfill all 'Mother's Day Contest' requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the San Joaquin Joint Powers Authority. You may enter only once. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of the San Joaquin Joint Powers Authority.

7. Winner Selection and Notification: Winner will be selected by a random drawing under the supervision of the San Joaquin Joint Powers Authority. Winner will be notified based on the social media channel he or she commented or replied to respectively. For Facebook, Winner will be notified by Facebook Direct Messenger within one (1) day following selection of Winner. For Instagram, Winner will be notified by Instagram Direct Message within one (1) day following selection of Winner. For Twitter, Winner will be notified by Twitter Direct Message within one (1) day following selection of Winner. The San Joaquin Joint Powers Authority shall have no liability for Winner's failure to receive notices due to spam, junk email or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 1 day from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in the 'Mother's Day Contest' is conditioned upon compliance with any and all federal, state, and local laws and regulations.

Terms & Conditions: The San Joaquin Joint Powers Authority reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the 'Mother's Day Contest' should virus, bug, non-authorized human intervention, fraud, or other cause beyond the San Joaquin Joint Powers Authority's control corrupt or affect the administration, security, fairness,

or proper conduct of the 'Mother's Day Contest'. In such case, the San Joaquin Joint Powers Authority may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the San Joaquin Joint Powers Authority. The San Joaquin Joint Powers Authority reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the 'Mother's Day Contest' or violates these Terms & Conditions. The San Joaquin Joint Powers Authority has the right, in its sole discretion, to maintain the integrity of the 'Mother's Day Contest', to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by 'Mother's Day Contest' rules; or the use of bots, macros, scripts, or other technical means for entering.
